June 29th, 2006

A special meeting of the Township of Seguin Council was held June 29th, 2006 at the Township of Seguin Council Chambers. Mayor Conn presided with Councillors Graham, Jacklin, Jameson and Sainsbury present. Councillors Campbell and Swift sent their regrets.

2006-264 Sainsbury-Jacklin

“**THAT** the Council of The Corporation of the Township of Seguin does hereby convene this Special Meeting at 9:00 a.m. for the purpose of discussions regarding By-law No. 2005-073, being a by-law that establishes interim control on the use of lands, buildings and structures within the municipality for all development within 200 metres of lakes, rivers and Georgian Bay located in The Corporation of the Township of Seguin, the Draft Zoning By-law for the Township of Seguin and any other matters that may arise.”.

After the meeting was called to order Mayor Conn asked for approval of the agenda. Council approved the agenda as presented.

Mayor Conn requested that any disclosures of pecuniary interest be declared for the record. There were no disclosures of pecuniary interest declared.

Council discussed the public comments received on the Draft Zoning By-law and provided direction to Staff on amendments to the Draft By-law for the next public meeting. Council also directed the Director of Planning to request Darcy Dunal revise his boathouse concept drawing to illustrate a maximum of 40% roof area for dormers/gables.
